THE AFGHAN HOUND CLUB OF AMERICA RESERVES THE RIGHT TO TAKE CORRECTIVE ACTION against any individual(s) who engage in inappropriate conduct prejudicial to the interest of the sport of purebred dogs, or the Club, as determined by Club officials, and/or the Event Committee. Individuals who engage in disruptive or aggressive conduct at any event during the National Specialty will be subject to corrective action, including discipline and/or expulsion from the event. Should the Event Committee determine that expulsion is the appropriate course of action, refunds will not be given.

The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

DOGS PARTICIPATING- This trial is open to all Afghan Hounds over the age of 15 months that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs must be physically sound. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Due to space limitations ONLY Dogs that are entered in the trial are permitted on show grounds..

BITCHES IN SEASON are not eligible to participate or be in the Trial Room before or during competition. Entry fees will be refunded. Written verification from a veterinarian is required. Notification for refund of bitches in season must be made before the start of the trial. A Veterinarian's note AND Final Trial Confirmation for the dog must accompany any such refund request.

Fix and Go On (FNG) As outlined in AKC Obedience Rules and Regulations Effective 2/29/2021, FNG allows the handler to choose to use a "Fix n' Go" option once, which allows the exhibitor to immediately reattempt a single individual exercise. This allows the team to reattempt that one exercise, and then leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix 'N Go is not preentered; rather, it occurs during the course of the run.
